

Target Market Determination

For the Suzuki Financial Services Personal Fixed Rate Car Loan and SuzukiSecure Car Loan (ABN 63 002 407 703)

1. About this document

This target market determination (**TMD**) outlines to consumers and distributors the class of consumers for which this product has been designed, having regard to their objectives, financial situation and needs of the target market.

This document is not to be treated as a full summary of the product's terms and conditions and is not intended to provide financial advice. Consumers must refer to the Suzuki Financial Services Personal Fixed Rate Loan Contract Booklet – Standard Terms and Conditions and any supplementary documents which outline the relevant terms and conditions under the product when making a decision about this product.

Terms and Conditions to which this target market determination applies

This TMD applies to the Suzuki Financial Services Fixed Rate Car Loan and SuzukiSecure Car Loan referred to in the Personal Fixed Rate Loan Contract Booklet – Standard Terms and Conditions.

Date from which this TMD is effective

1 March 2026

2. Class of consumers that fall within this target market

This product is designed for a class of consumer who want finance to purchase a vehicle predominately for personal, domestic, or household use (including vehicle accessories, on-road costs and fees that can be financed), and want an interest rate that is fixed for the loan term. There are two variations of this product: (1) the Personal Fixed Rate Car Loan and (2) SuzukiSecure Car Loan.

Excluded class of consumers

This product has not been designed for consumers who want to:

- Part with possession or control of the vehicle by way of lease, transfer, assign or lend;
- Modify the vehicle in a way that may void any warranty or cause the vehicle to be unroadworthy, illegal or not fully covered by insurance;
- Transport the vehicle from mainland Australia or Tasmania; or
- Use the vehicle to provide commercial transport services, such as hire-car, or taxi.

Consistency between target market and the product

This product is likely to be consistent with the likely objectives, needs and financial situation of the class of consumers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of consumers.

3. How this product is to be distributed

Distribution channels

This product is designed to be distributed through the following means:

- By our accredited Motor Vehicle Dealer network acting as agents for Suzuki Financial Services under Suzuki Financial Services' Australian Credit Licence; and
- Directly by Suzuki Financial Services through the Suzuki Financial Services National Direct Centre, either over the phone, via email or mail.

Distribution conditions

These products may only be distributed where the following conditions are satisfied:

- The consumer meets Suzuki Financial Services' eligibility and lending criteria, including being assessed by Suzuki Financial Services as having the capacity to meet the proposed loan repayments.
- The consumer has been provided with the required disclosure documents, including the Terms and Conditions and Credit Guide.
- Key product conditions have been explained to the consumer, and the product and loan structure align with the consumer's requirements and objectives.
- The consumer understands and acknowledges the key features of the product and loan, including the interest rate, fees, loan term and repayment structure (including any final balloon payment).
- Where the consumer selects the SuzukiSecure Car Loan, the final balloon payment has been explained to the consumer, and the consumer has indicated how they intend to meet that obligation.

Persons who distribute these products must:

- Be accredited by Suzuki Financial Services and be an employee of a dealership acting as an agent of Suzuki Financial Services, or be an employee of Suzuki Financial Services.
- Report any complaints received about these products or the finance sales process to Suzuki Financial Services as soon as practicable.
- Be adequately trained and deemed competent by Suzuki Financial Services to offer the products described in this TMD, including to explain the key product features and restrictions.
- Be subject to Suzuki Financial Services monitoring and supervision arrangements, including requirements to complete any continuing professional development training as directed by Suzuki Financial Services.

Adequacy of distribution conditions and restrictions

Suzuki Financial Services have determined that the distribution conditions and restrictions will make it likely that the consumers who purchase the product are in the class of consumers for which it has been designed. Suzuki Financial Services consider that the distribution conditions and restrictions are appropriate and will assist distribution in being directed towards the target market for whom the product has been designed.

4. Reviewing this TMD

We will review this TMD in accordance with the below:

Initial review	Within 12 months of the original effective date.
Periodic reviews	At least every three years from the last review to ensure it remains appropriate.
Review triggers or events	Any event or circumstances arise that would suggest the TMD is no longer appropriate. This may include (but is not limited to): <ul style="list-style-type: none">• A material change to the design or distribution of the product, including related product documentation and acceptance/lending criteria;• The occurrence of a significant dealing;• Distribution conditions found to be inadequate;• Significant changes in metrics including, but not limited to, material adverse trends in internal delinquency data, cancellations, product switching, defaults on repayments, late repayments and/or complaints;• Identified systemic issues in the product or across the product lifecycle;• Material external events such as relevant litigation, adverse media coverage or regulatory attention which may suggest the TMD is no longer appropriate; or• Relevant feedback, information or notification received from a distributor, regulatory body such as ASIC or APRA, or other interested parties.

This TMD will be reviewed within 10 business days of the occurrence of any review trigger.

5. Reporting and monitoring this TMD

We may collect the following information from our distributors in relation to this TMD.

Complaints	Distributors will refer all complaints in relation to the product covered by this TMD to Suzuki Financial Services as and when a complaint arises or the distributor becomes made aware of a complaint.
Significant dealings	Distributors will report if they become aware of a significant dealing in relation to this TMD as soon as practicable but not more than 10 business days after.
System Controls	Suzuki Financial Services will review and assess the adequacy of distribution conditions and restrictions to ensure alignment with the TMD and that they are working effectively on a quarterly basis.
Transaction Data	Suzuki Financial Services will review transaction data relevant to the TMD on a monthly basis and report any significant dealing in relation to this TMD.
Sales Practice Monitoring	Suzuki Financial Services will review the results of the bi-annual Compliance Competency Assessment and report any significant dealing in relation to this TMD.
